I am directed by order of the Governor to say that the Governor has been pleased to accord administrative approval and financial sanction out of the **SCA of 2013-14** to an expenditure of **Rs. 4,00,00,000/-** (Rupees four crore) only for Construction of motorable bridge across river Tangon at Radhikapur under Kaliaganj Block, Phase -III, in the districts of Uttar Dinajpur as part of development work under Border Area Development Programme (BADP) :-

2. Sanction is also accorded to the allotment to the District Magistrate, Uttar Dinajpur for the above purpose for the amount of Rs. 4,00,00,000/-.

The District Magistrate, Uttar Dinajpur will act as Drawing and Disbursing Officer in respect of the funds for execution of schemes by him.

He is also authorised to re-allot necessary funds to the executing agencies direct on the authority of this order from the sanction accorded herein above.

3. The scheme will be implemented by the District Magistrate, Uttar Dinajpur after due observance of the required formalities for estimate, tender, security etc.

4. The charge is debitible to the head "4575 - Capital Outlay on Other Special Areas Programme - 60 - Others - 800 - Other Expenditure - SP - State Plan (Annual Plan and Twelfth Plan) - 007 - P.W. (Road) Sector (CS) (BADP) [PL] - 53 - Major Works / Land and Buildings" [**Code: "4575-60-800-SP-007-PW(Rds)-53-V"**] under Demand No. 27 in the Budget Provision during the financial year 2013-14.

5. The scheme(s) for which the above mentioned fund is hereby sanctioned is/are required to be completed / executed as early as possible. Quarterly Progress Report, both in financial and physical terms along with Utilisation Certificates are to be submitted to this Department in time. A photograph of the completed projects, duly authenticated by the executing agency should be sent to this Department along with the final Utilisation Certificate.

6. This order is issued with the concurrence of Finance Department of this Government vide their U.O. No. Group-'N'/ 0730 dated 19.07.2013.
