**AND**


**WHEREAS**, the Block Development officer has informed the necessity to notify this specific location for containment.

**Now**, therefore, in exercise of the power conferred upon the undersigned under Section 34 read with Section 26 of the Disaster Management Act, 2005 and vide clause-I of the order of Chief Secretary as mentioned above, the following area of Cooch Behar District is hereby notified as Micro Containment Zone:

All concerned are hereby requested to have a meeting with all the relevant stakeholders further on regular basis for ensuring smooth implementation of the directives from the Govt. of West Bengal regarding Micro Containment Zone(s).
