Hence the following Containment Zones are notified in Jhargram Municipality and Block area :-



- 1) Only Medical establishments, Medicine shops and ATMs will remain open in this area, for residents of the area.
- 2) All offices in this area will remain closed except those dealing with Court, Police, Fire, Electricity, Water, Media and Emergency services. Banks may remain open from 10:00 am to 02:00 pm.
- 3) No movement of vehicles. will be allowed except for ambulance and health emergencies.
- 4) Agri-marketing Department will ensure supply of vegetable/fruits for purchase, at fair price, just outside the zone.
- 5) Entry and exit of persons to and from this zone will not be permitted except for health emergency and essential services.

This order will be strictly enforced by administrative and police authorities.

Persons violating this order will be liable for imprisonment and fine by the competent Court under National Disaster Management Act, 2005 (Jail upto two years u/s 51 and fine) and IPC Section 188 (upto 6 months jail and Rs. 1,000.00 fine).
