5. The successful tenderer will have to execute an agreement after depositing earnest money @ 2% (Two Percent) of the quoted amount in the shape of Bank draft in favour of **West Bengal State Marketing Board Fund/Cash**
6. The successful tenderer will have to execute an agreement (with 2 sets of non-judicial stamp paper of Rs.100/- after depositing agreement fees of Rs.500/- in the shape of Bank draft in favour of **West Bengal State Marketing Board Fund/Cash**.
